



## Overnight and Daycare Boarding Contract

**This is an agreement between Wag-On-Inn, and the pet owner whose name is \_\_\_\_\_ and whose address is \_\_\_\_\_**  
**And whose signature appears on Page 2 (hereinafter referred as “Owner”).**  
**Following are the same terms of agreement for the stay of the Owner’s pet (Name) \_\_\_\_\_ (the “Pet”) as an overnight boarding or daycare guest of Wag-On-Inn, Inc.**

- 1.) By signing this Agreement and leaving your pet with Wag-On-Inn, owner certifies to the accuracy of all information provided to Wag-On-Inn in writing or orally about the pet. Wag-On-Inn reserves the right to deny admittance to the pet or any pet for any reason at any time.
- 2.) Owner specifically represents that he or she is the sole owner of the Pet, free and clear of all liens and encumbrances.
- 3.) Owner understands that Wag-On-Inn reserves the right to refuse admittance to any pet that lacks proof of vaccinations and fecal exam results, displays signs of untreated or potentially contagious conditions, demonstrates aggressive behavior, or who fails our standard health and temperament policies.
- 4.) While Wag-On-Inn makes every effort to ensure the pets staying at Wag-On-Inn are healthy by requiring their owners to affirmatively represent that all vaccines for their pet are current, Owner acknowledges and is aware that the employees of Wag-On-Inn are not veterinarians and do not have backgrounds in animal medicine and are not expected to diagnose or detect illnesses in the pets that are staying at Wag-On-Inn. In addition, Owner acknowledges and is aware that vaccines do not protect against communicable illnesses that may affect a pet. Owner acknowledges and agrees that they are assuming all risk of illness, disease, harm or otherwise to their pet by allowing their pet to stay at Wag-On-Inn.
- 5.) Owner agrees to pay the pet care service rate in effect on the date the Pet is checked into Wag-On-Inn.
- 6.) Owner agrees that the Pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed by both parties.
- 7.) Owner agrees to be solely responsible for any and all acts or behavior of the Pet while in the care of Wag-On-Inn, to include payment of costs for injury to staff or other animals or damage to facilities caused by the Pet. Owner further indemnifies Wag-On-Inn against any claims made against Wag-On-Inn or its employees or members or other agents or losses or damages of any kind suffered by Wag-On-Inn as a result of the Owner’s failure to inform Wag-On-Inn of any pre-existing condition the Pet may have (such as illness or aggression problem) or which were otherwise caused by the Pet.

8.) In the event of medical emergency, Wag-On-Inn will attempt to contact the Owner, and the Pet's personal veterinarian as well as the emergency contact provided by Owner; however, such an emergency might not provide the time to do so prior to administration of care. Owner authorizes Wag-On-Inn at the sole discretion of Wag-On-Inn management, to obtain whatever medical treatment is deemed necessary for Pet from any qualified veterinarian and to transport pet to and from the veterinarian when Wag-On-Inn deems such medical care is important to Pet's health. Owner grants Wag-On-Inn or its employees or agents full power of decision making involving the medical treatment of Pet and agrees to pay all costs. This applies to any claims or injures or damages related to such medical care or transport

I agree that if my pet is left for ten days beyond the date of scheduled checkout that my pet may be put up for adoption at the discretion of Wag-On-Inn, Inc unless notification is received from owner. Initial \_\_\_\_\_
